Cement with 425 sx Lite Premium Plus w/5# Gilsonite, 1/4# flocele, and 200 sx Premium Plus + 2% CaCl2. Circulate to surface. WOC 24 hrs. Test casing to 1000 psi f/30 min. held ok. Drill 7-7/8" hole to 7600'. Ran 152 jts 5-1/2" 15.5#, J-55, LTC & 33 jts 5-1/2", 17#, J-55 LTC casing set @ 7562'. Cement with 780 sx Premium Plus + 2% Zone Seal 2000 w/Nitrogen. TOC by Temp Survey 3020'. Release Rig @ 4:00 p.m. 8/18/05. Prep for completion.
