Cemented w/ 600 sx Class C + additives 12.8 ppg, 2.12 cu.ft./sx lead slurry; 200 sx Class C + additives 14.8 ppg, 1.35 cu.ft./sx tail slurry. No cement circ. Notified BLM. Ran temperature survey, TOC @ 200'.

8/13/05 RU 1 1/4" tubing, mix and pump 70 bbl viscous sweep containing 10 sx each of paper and cottonseed hulls + 5 sx of Baro-Seal. Pumped 200 sx of Class C + 3% CaCl2. Lost returns.

RIH and tag @ 65'. Pumped 25 bbls w/ same LCM blend as before. Pumped 14 bbls Class C + 3% CaCl2 cement. Circ 5 bbls clean cement.

8/15/05 Tested casing to 2000 psi for 30 min. Test good.
