BOPCO, L.P. respectfully wishes to recomplete the well within 1 year of the approval of this Sundry. This well has mechanical integrity and does not show a pollution threat. BOPOCO, L.P. failed to submit proper paperwork in the time frame indicated at a meeting between BOPCO and the BLM. It is our wish that these plans be accepted so that we may bring this well into compliance as soon as possible. A 5-1/2" 10-K CIBP was set @ 7,478' on 7-9-12 (50' above top Bone Spring perf at 7528') and capped w/35' Class H cement; tagged PBTD @ 7424'.

Plans are to drill a lateral in the Delaware or Bone Spring formations.

- 1) Tag PBTD and bring cement up 250'+, 25 sacks through tubing as per BLM request.
- 2) Set a 25 sack plug, CL C cement @ 6,663 - 6,916' (top Bone Spring).
- 3) Cut and pull 5-1/2" csg. @ 4050. Set 300 sack plug, CL C cement for casing stub, shoe and
