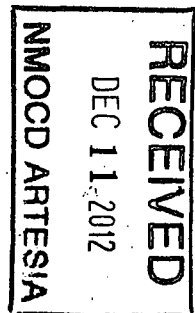

Cemented stage 1 with 640 sx Class "C" + 0.35% D013 + 0.2% D046 + 0.125#/sx D130 + 0.1% D208 + 6% D020 (yld 1.96, wt 12.6). Tailed in with 850 sx TXI Liteweight + 0.2% D046 + 0.5% D112 + 1.5% D174 + 0.1% D208 + 0.5% D800 (yld 1.82, wt 13). Circulated 480 sx to half round. Opened DV tool with 1900 psi and circulated. Cemented stage 2 with 560 sx Class "C" + 6% D020 + 5% D044 + 0.2% D046 + 0.125#/sx D130 (yld 2.06, wt 12.6). Tailed in with 180 sx Class "C" + 2% D020 + 5% D044 + 0.2% D046 + 0.125#/sx D130 (yld 1.37, wt 14.2). Circulated 82 sx to pit.
