Stage 2: Lower Middle Brinebry: Perforate 5425' to 5614', 56 holes, frac with 3318 gals 15% HCL, 4857 bbls slurry and 170,244# sand

Stage 3: Upper Middle Brinebry: Perforate 5265' to 5367', 48 holes, frac with 3402 gals 15% HCL, 4938 bbls slurry and 171,040# sand

Stage 4: Upper Brinebry: Perforate 5065' to 5182', 48 holes, frac with 2940 gals 15% HCL, 4776 bbls slurry and 158,093# sand

Stage 5: Paddock: Perforate 4708' to 4972', 48 holes, frac with 1000 gals 15% HCL, 5566 bbls slurry and 224,010# sand

Shut well in.

12-8-2012 Drill out safety plug and composite plugs, circulate well clean, 2 3/8" tubing set at 4590'.

12-9-2012 Waiting on Swab Rig

12-11-2012 Swab Rig on location, recovering frac water
