Spudded well on 12/16/12. Drilled 12-1/4" hole to 360'. Set 8-5/8" 24# J-55 csg @ 360'. Cmted w/335 sx (449 cf) cl "C" cmt w/2% Cacl₂, 0.005# static free, & 1/4# C/F. Circ 100 sx cmt to pit. On 12/17/12, pressure tested 8-5/8" csg to 1850 psi. After 30 min, pressure was 1680 psi.-test-OK.

Drilled 7-7/8" hole to TD4700' on 12/21/12. Set 5-1/2" 17# J-55 production csg @ 4697'. Cmted w/lead 280 sx (372 cf) 35:65 poz "C" cmt w/5% salt, 0.20% R-3, 5# LCM-1, & 1/8# cello flake & tailed w/650 sx (865 cf) cl "C" cmt w/0.55% R-3 & 0.25# Cello Flake. Circ 103 sx cmt to pit. Released drilling rig on 12/23/12. Plan to pressure test 5-1/2" csg during completion operations.
