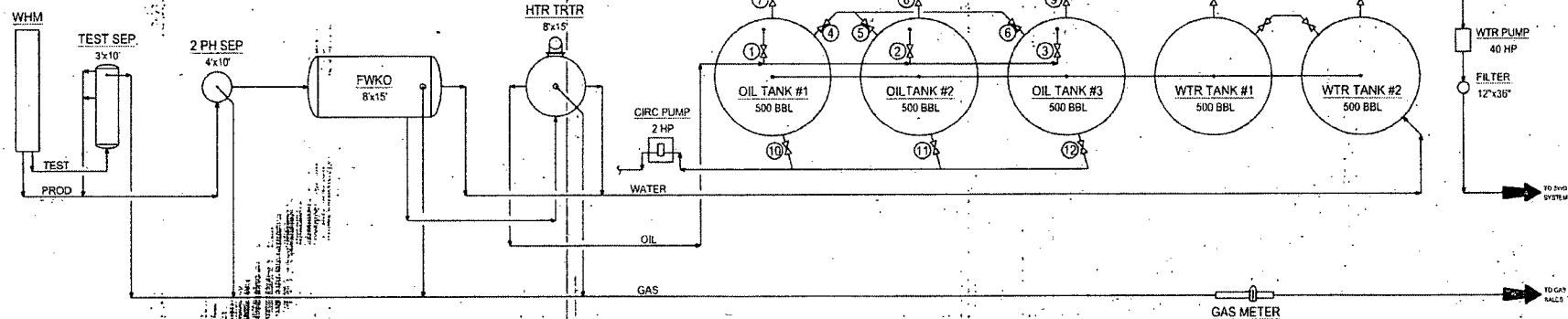

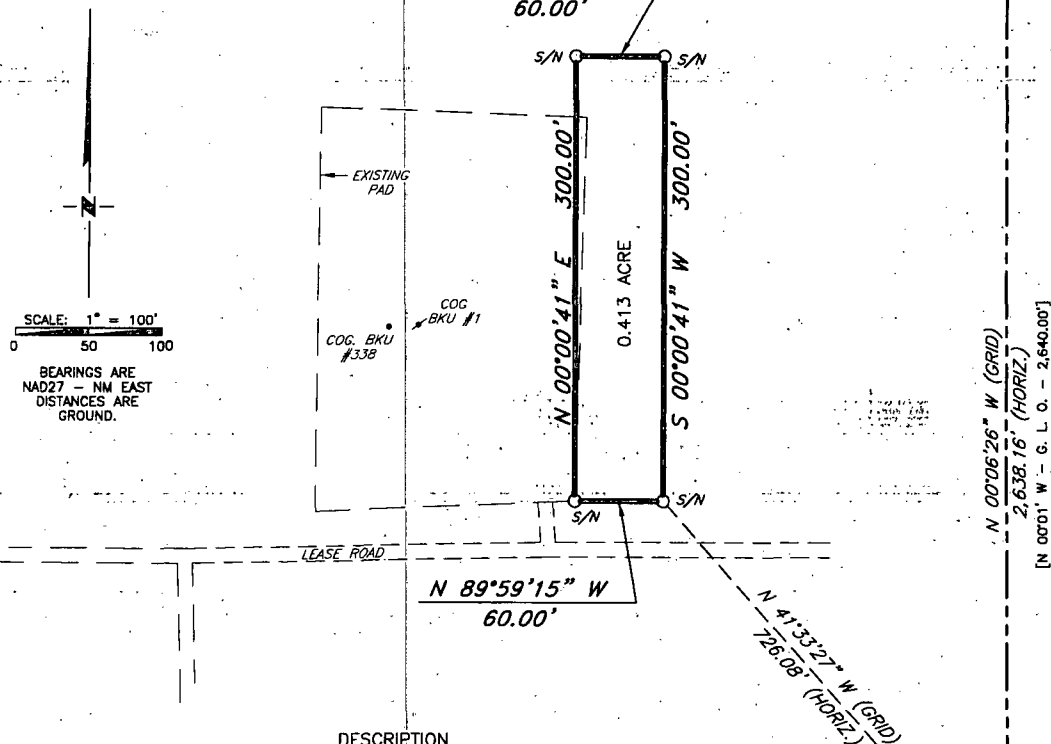

DESCRIPTION

A tract of land situated within the Southeast Quarter of Section 23, Township 17 South, Range 29 East, N. M. P. M., Eddy County, New Mexico. Said tract of land being more particularly described by metes and bounds as follows:

Thence N 41°33'27" W, 726.08 feet to a spike nail set for the Point of Beginning and the Southeast corner of the tract of land herein described;

Thence N 89°59'15" W, 60.00 feet to a spike nail set for the Southwest corner of the tract of land herein described;

Thence N 00°00'41" E, 300.00 feet to a spike nail set for the Northwest corner of the tract of land herein described;

Thence S 89°59'19" E, 60.00 feet to a spike nail set for the Northeast corner of the tract of land herein described;

Thence S 00°00'41" W, 300.00 feet to the Point of Beginning;

Said tract of land containing 18,000 square feet or 0.413 acre, more or less.
