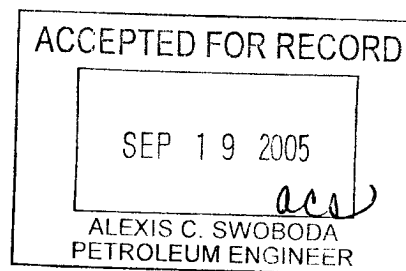

Cement with 650 sx Premium Plus + w/Nitrogen. TOC by Temp Survey 4580'.
