Cemented 1st stage w/ 500 sx 50:50 POZ C, 11.9 ppg, 2.45 cu.ft./sx lead slurry; 225 sx Class C, 14.8 ppg, 1.33 cu.ft./sx tail slurry. Open DV tool and CIRC through DV tool, 11 sx to surface. Cement 2nd stage w/ 1850 sx 50:50 POZ C, 11.9 ppg, 2.45 cu.ft./sx lead slurry; 200 sx Class C, 14.8 ppg, 1.33 cu.ft./sx tail slurry. Close DV tool, CIRC 232 sx to surface. WOC 21 hrs.
