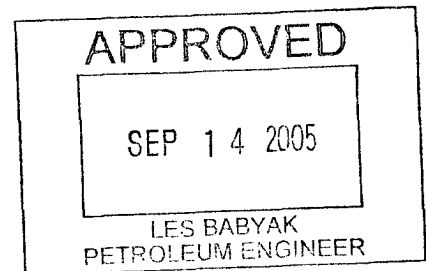

Intermediate Casing - Use 9-5/8" 40# J-55 instead of the permitted 9-5/8" 40# P-110/N-80.

Production Casing - No Change.
