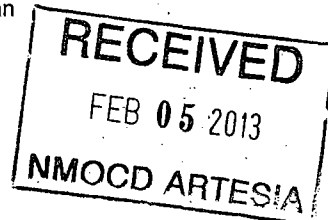
This well was completed & tested in the Wolfcamp with initial GOR of 6429. This dedicates it as an oil well. MOC retested well on 11/18/2012 as follows:
