## NOTICE OF VIOLATION - Inspection

**Comments on Inspection:** Open piping coming into tank battery from the south (buried until just before berm) appears to have drained produced water inside bermed area of tank battery. West side of produced water tank and southwest, bottom half of middle tank are wet, pooled liquids are around the base of the water tank. Western side of bermed area is wet across entire length.

Remediation is required. Submit C-141. Contact NMOCD District 2 Environmental Compliance Officer with site ranking and remediation work plan.

Notify NMOCD District 2 Office 48 hours prior to any remediation work or prior to taking samples where results of the samples may be submitted to OCD.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.
