We installed a dry hole marker for PLU 367H and PLU 367 and poured 4 cubic yards of ready mix cement into cellar, rat hole and mouse hole on 1/3/2012. Joe Baldarez was notified to inspect P&A job. Once approved by inspection the cellar was backfilled to surface with caliche.
