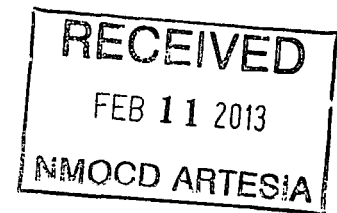
This line is expected to carry 6 MMCFD at 500 psi.

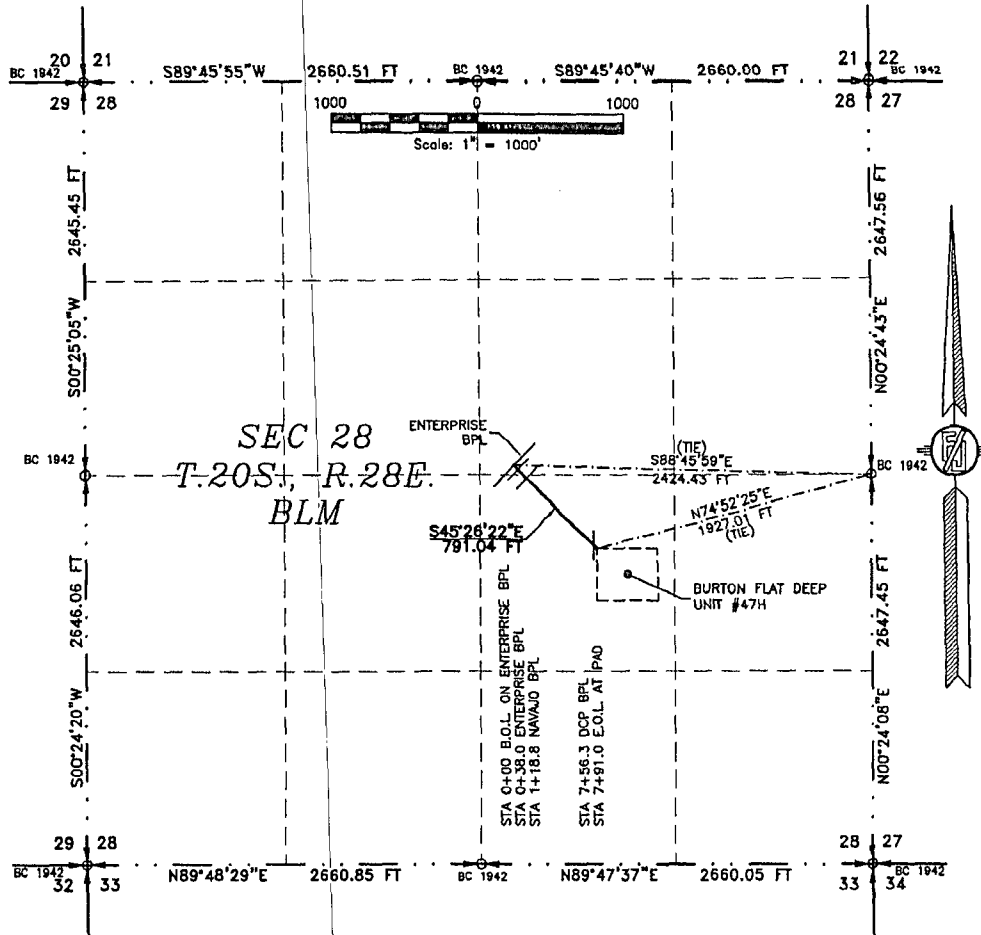
