2/04/2013 Rig up. Lay down rods. Dug out cellar and worked on removing wellhead cap.

2/5/2013 Installed BOP and tallied tubing OOH. Make scraper run. RIH and attempted to set 4 1/2" CIBP at 2302'. Would not set. Stacked the tubing in the rat hole and tried to get rid of the CIBP. POOH with tubing and the CIBP was still on the setting tool but damaged badly. RIH with tubing and SION.

2/5/2013 Spotted 25 sx class c cement at 2302' and WOC. Tagged cement at 1894'. Circulated mud. POOH to 1821' and spotted 25 sx class c cement. Laid down tubing and perforated at 376'. Established circulation and pumped cement to perms at 376'. Pumped 175 sx Class c and never got cement to surface. Well had good circulation the entire time pumping cement. SION.

2/6/2013 Cut off well head and "one inched" annulus from 60'. Filled up 4 1/2" casing to surface. Good cement on both sides. Installed marker and cut off anchors.
