Due to an unacceptable level of Nitrogen found in the gas from this specific well, it has been necessary to temporarily Shut-In this well. It is our understanding that Transwestern has dictated the "acceptable level" of nitrogen in the gas that they will accept from Agave Energy Company (Purchaser).

It should be noted that nitrogen is inherently found throughout the Pecos Slope Field.
