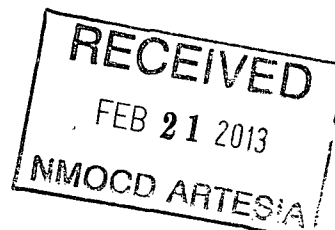

2/8/13 – Spotted 90 sx Class "C" Neat cement to 500'. PUH to 500'. Pumped 60 sx Class "C" Neat cement. Circulated to surface. ND BOP. Topped out casing.  
2/14/13 – Dug out cellar and cut off wellhead. Installed dry hole marker. Filled cellar. **WELL IS PLUGGED AND ABANDONED.**
