- Lime Rock Resources contracted Talon/LPE to do reclamation activities on the closed drilling pit at the West Red Lake No. 44, an active well.
- The surface of the closed drilling pit area was bladed to prepare for the installation of a liner. Rock and debris was deep buried into the drilling reserve pit area. A composite 20 millimeter liner measuring 125-feet long by 145-feet wide was installed over the closed drilling pit area. The edges of the liner was keyed a minimum of 3-feet deep into a trench excavated at the boundaries of the closed drilling pit area.
- A minimum of 2-foot of new soil was placed over the top of the 20 mil liner in the closed drilling pit area. The soil lift was contoured to match the surrounding terrain.
- A 1-foot berm was constructed up gradient of the drilling pit to divert run off waters for erosion control.
- The downsized portion of the location and drilling pit was seeded on January 31, 2013 using the BLM seed mixture No. 3 and 4.
