Mixed @ 14.3#/g w/1.34 yd. Plug down @ 4:45 AM 02/03/13. Circ 75 sks of cement to pit. WOC. Tested BOPE to 3000# & Annular to 1500#. At 11:30 PM 02/03/13, tested csg to 1500# for 30 mins, held OK. Drilled out with 8 3/4" bit.
