It is the operator's intent to initiate interim remediation to reduce the size of this wellpad, and related areas of surface disturbance, in preparation to revegetate the interim remediated area and pit in accordance with the COA. A previous attempt at revegetatng the pit area has been unsuccessful. In recognition of that failure, Read & Stevens has retained the services of Organic Technologies, Inc. to serve as our agronomy consultant and hands-on contractor, due primarily to their success with golf courses and landscape issues on Palm Island in the Emirate of Dubai, an environment similar to and with many of the same issues as this site.. Their approach will be to prepare a seedbed that will optimize the limited precipitation and preclude erosion, as well as limit upward migration of deleterious mineral salts. After this, the area will be planted with the Gypsiferous Soils seed mix as you have specified when they deem it to be an auspicious time relative to growing seasons and soil moisture. It is anticipated to do the seedbed preparation work in conjunction with similar work on the Hot Dog 23 Federal Wells 2 and 3, and the pit closure of Hot Dog 23 Federal Well 4. The seedbed preparation work will commence as soon as possible following completion of the coarse earthmoving work on the three referenced sites.
