Spud well on 3/4/13. Drilled 12-1/4" hole to 460'. Landed 8-5/8" 24# J-55 csg @ 453'. Cmted w/335 sx (449 cf) "C" cmt w/2% CaCl2 & 0.125# CF. Did not circ cmt. Temp survey indicated cmt @ 36'. Ran 1" tbg into annulus & pumped 100 sx "C" cmt & circ 47 sx cmt to surface. On 3/7/13, PT 8-5/8" csg to 1545 psi-dropped to 1474 in 30 min.

Drilled 7-7/8" hole from 8-5/8" csg shoe to 4296' on 3/13/13. Ran open hole logs. On 3/14/13, landed 5-1/2" 17# J-55 csg @ 4296'. Cmted lead w/300sx (570 cf) 35/65 poz "C" cmt w/1/4#/sx CF, 5% salt, 5# LCM-1, 0.4# CD-32, 0.005# static free, & 0.35% R-3. Tailed w/600 sx (792 cf) "C" cmt w/0.3% R-3, 0.005# static free, & 0.25#/sx CF. Circ 183 sx cmt to pit. Released drilling rig on 3/14/13. Plan to pressure test the 5-1/2" csg before completion operations.
