Drill 6 1/8" hole from 5000' to +/-5121', building curve at 12 degree/100' over +/-774' to horizontal at 5895'MD/5600'TVD. Drill 6 1/8" lateral section in a Westerly direction for +/-2885' lateral to TD at +/-8700'MD/5551'TVD. Run 4 1/2" production liner from 4875' (125' liner overlap) to TD and cemented with 155 sxs Halliburton "H", yeild 2.62cf/sk, wt. 15ppg.

All other components of the drilling plan will remain the same.
