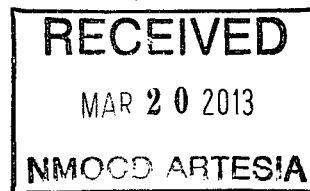

Mr. Dade,

Term (7) of Order No. R-3357-C dictated that, Alamo Permian Resources, LLC, ("Alamo") was obligated to attempt to locate, reenter, and re-plug the Donnelly Kelly State Well No. 1 (API No. 30-015-02367). To date, Alamo has performed the following in sequential order in an attempt to fulfill the above described obligation:

1. Alamo excavated a 14' hole around a potential P&A marker but found no sign of cellar, conductor pipe, or previous wellbore.
2. Alamo hired certified surveyors to re-stake the location based on the permitted and approved footage calls found in both Alamo's lease files and the NMOCD records.
3. Alamo excavated one 14' long ditch from the staked location to the previously excavated location but found no indication of a cellar, conductor pipe, or previous wellbore.
4. Alamo hired certified surveyors to re-stake the permitted location based on latitude and longitude coordinates supplied by the NMOCD.
5. Alamo excavated a 1' wide ditch 20' long but found no indication of a cellar, conductor pipe, or previous wellbore.
6. Alamo excavated four (4) ditches 1' wide and 20' long from the re-staked latitude and longitude based location to the re-staked location based on the permitted footage calls but found no indication of a cellar, conductor pipe, or previous wellbore.

Attached for your benefit are pictures of the trenching activity that we have performed in an attempt to locate the wellbore. Alamo believes that the above dictated operations illustrate a satisfactory attempt to locate, reenter, and re-plug the Donnelly Kelly State Well No. 1 (API No. 30-015-02367). Alamo requests that the Artesia District office inspectors acknowledge we have thoroughly attempted to locate the wellbore, have fulfilled the obligation dictated under term (7) of Order No. R-3357-C, and release us from any future obligations to locate the Donnelly Kelly State Well No. 1.
