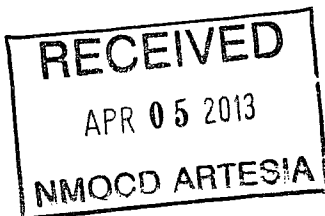

Condition of Approval to Flare Gas

1. Request approval to flare gas by submitting NOI to Flare Gas
2. Submit Subsequent Report with actual volumes of gas flared for each month gas is flared.
3. Report all volumes on OGOR reports.
4. Comply with NTL-4A requirements
5. Subject to like approval from NMOCD
- 6. Flared volumes will still require payment of royalties**
7. Install gas meter on vent/flare line to measure gas prior to venting/flaring operations if it is not equipped as such at this time. Gas meter to meet all requirements for sale meter as Federal Regulations and Onshore Order #5.
8. This approval does not authorize any additional surface disturbance.
9. Submit updated facility diagram as per Onshore Order #3.
10. Approval not to exceed 90 days for date of approval.
