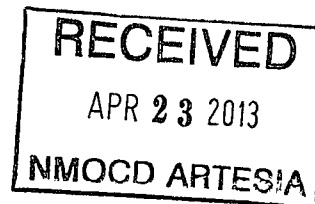

Mixed @ 14.8 #/g w/1.33 yd. Plug down @ 3:30 AM 03/25/13. Did not circ cmt. Lift pressure # 950# @ 2.8 BPM. Ran temperature survey indicating TOC @ 60'. Tested dsg spool pack-off to 2000#. Tested BOPE to 3000# & Annular to 1500#. At 10:00 AM 03/26/13, tested csg to 1500# for 30 mins, held OK. Drilled out with 6 1/8" bit.
