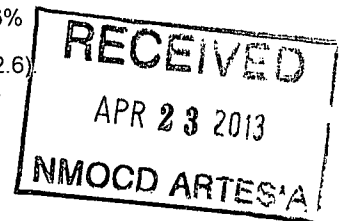

Tailed in with 360 sx 50/50 Poz C + 0.03% D208 + 5% D44 + 0.2% D46 + 1% D020 (yld 1.36, wt 14.2).
