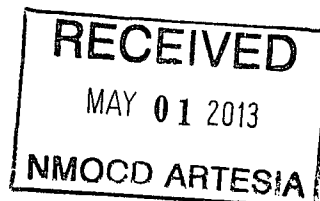

4/18/13 - NU BOP. POOH with tubing. RIH with bit and scraper to 1450'. RIH with perf sub to 1450'. Spotted 115 sx cement with 4 bags Calcium. RIH to tag plug, did not tag. Set a 4-1/2" CIBP at 1200'. Loaded hole with 31 bbls. Pumped 135 sx cement plug to surface. ND BOP. Topped off well to surface with cement.

4/29/13 - Dug out cellar and cut off wellhead. There was no cement between 7" and 10-3/4" casing, brought cement pump over and filled with 13' cement, all strings full. Installed dry hole marker. Filled cellar. **WELL IS PLUGGED AND ABANDONED.**
