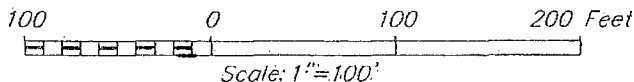

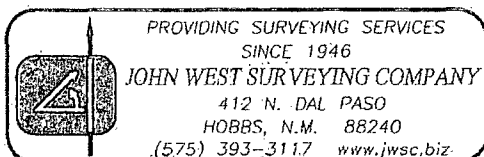

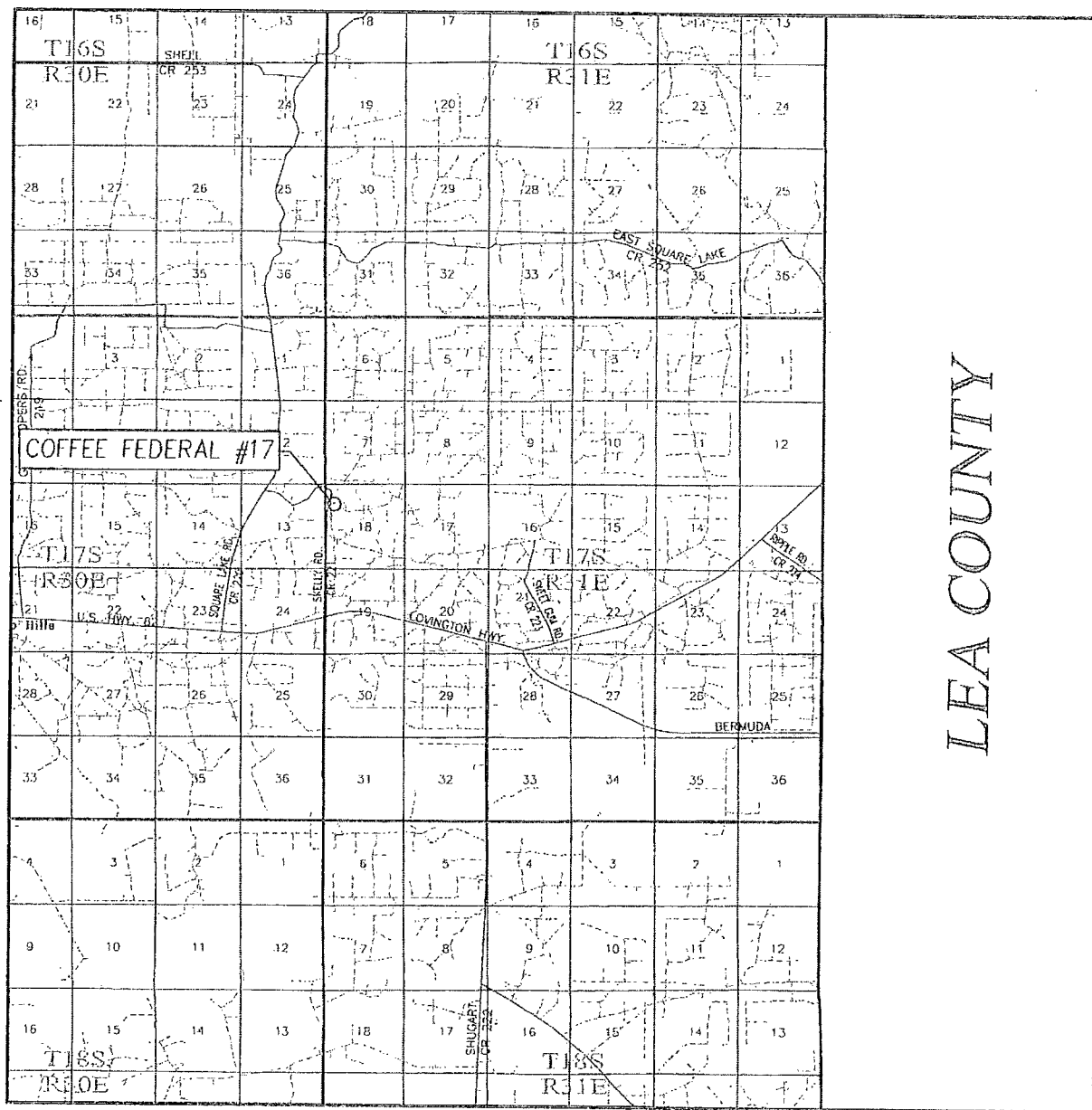

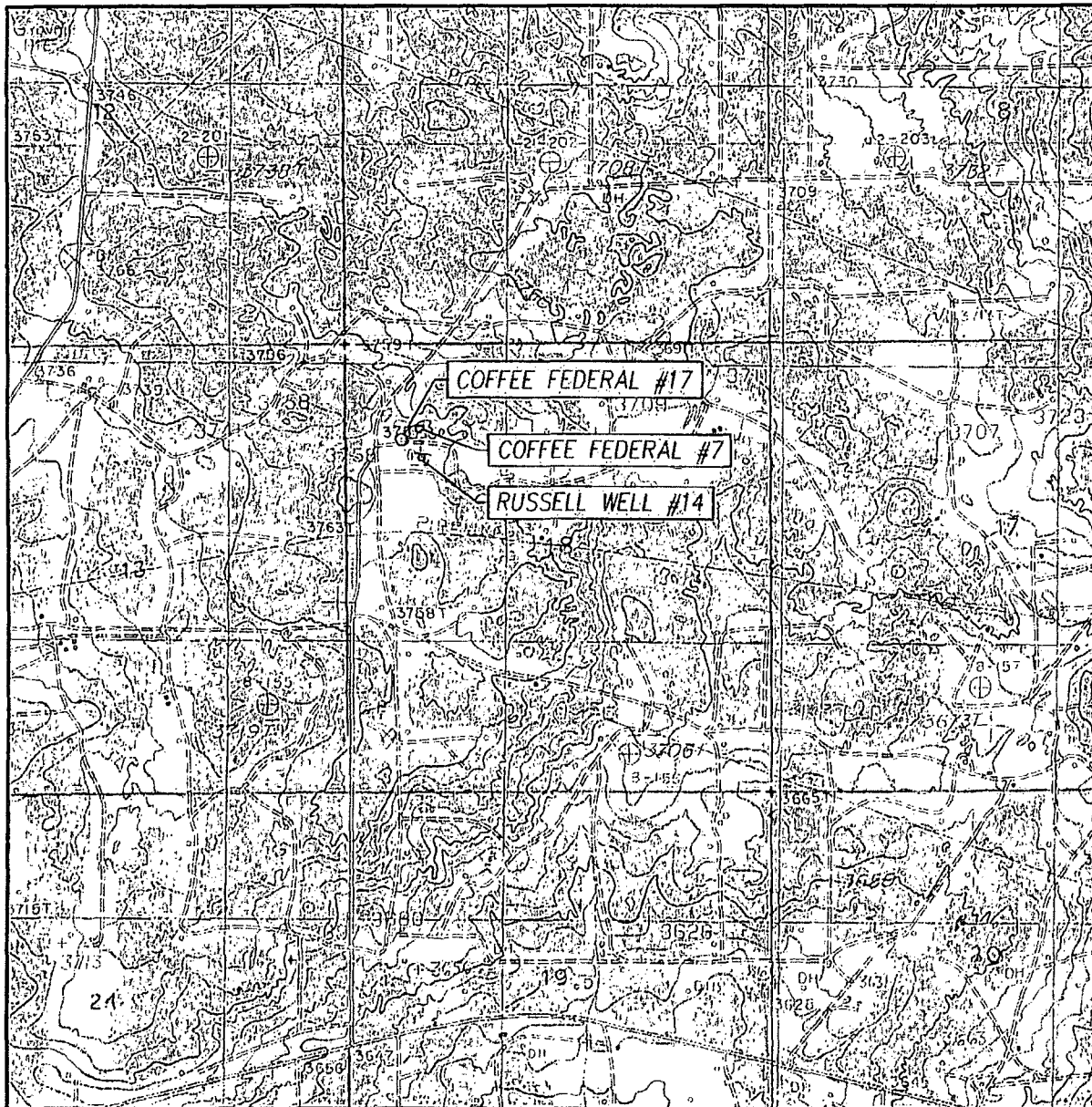

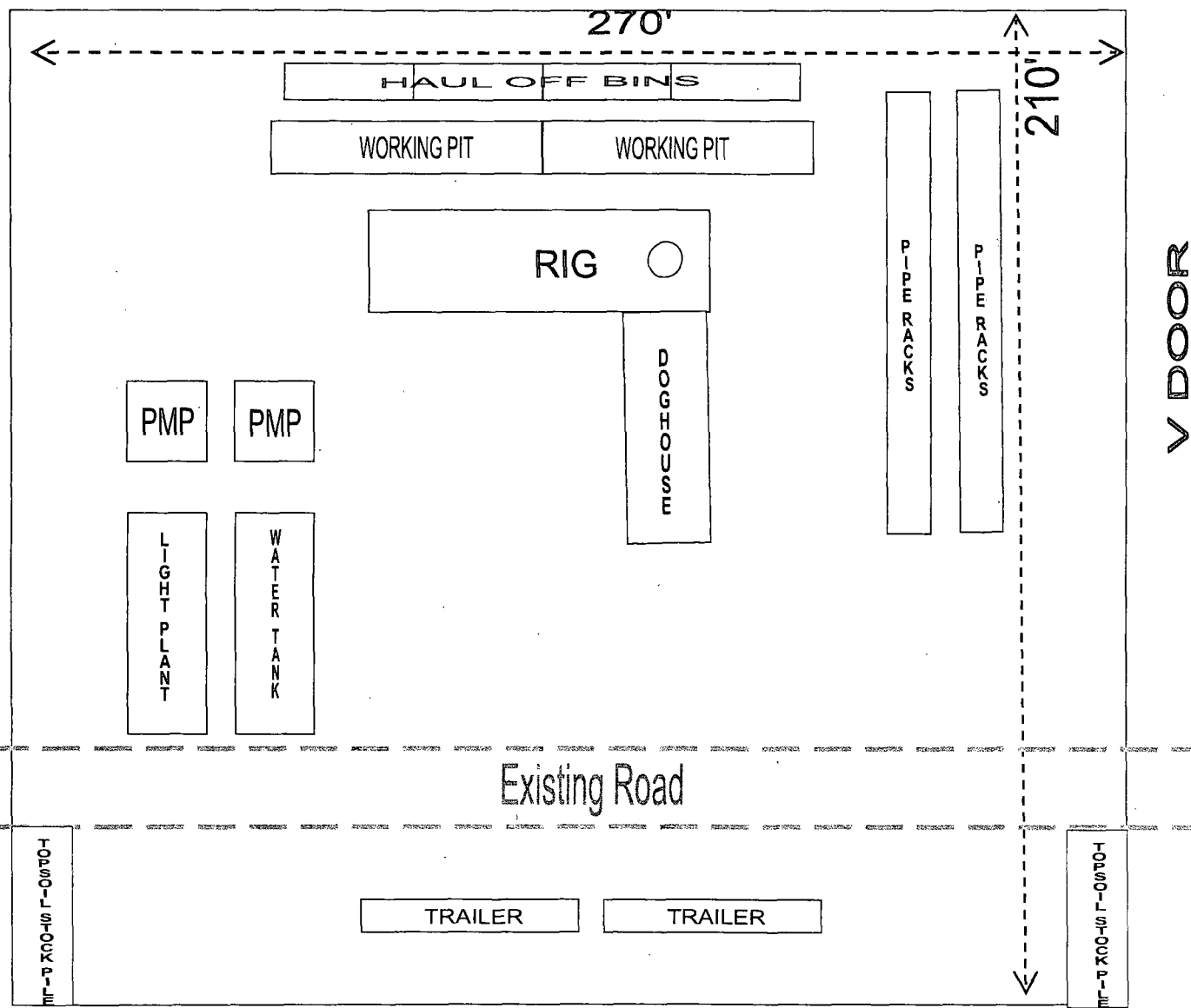
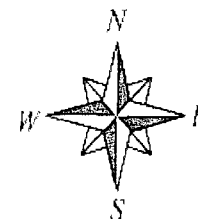
U.S.G.S. TOPOGRAPHIC MAP
