Cmted w/lead 280 sx (532 cf) 35:65 poz "C" cmt w/5% salt, 6% gel, 2% R-3, & 0.125# CF & tailed w/625 sx (825 cf) cl "C" cmt w/0.5% PF13, 2% PF-167, 0.2% PF-65, & 0.125# PF-29. Circ 157 sx cmt to pit. Released drilling rig on 9/29/13. Plan to pressure test 5-1/2" csg before completion operations.
