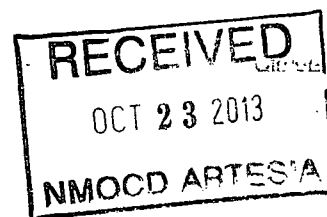

9/8/13 - NU BOP. Tested casing to 1500 psi, tested OK. Tagged cement at 690 ft. Tested casing to 1450 psi, ending at 1305 psi. WOC 33 hours. Reduced hole to 12-1/4 inch and resumed drilling.
