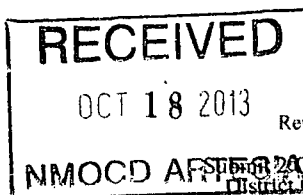

Describe Cause of Problem and Remedial Action Taken.\*

A poly flow line ruptured releasing a produced water/crude oil mixture. Well was turned off, casing and tubing pressure were shut in, inlet valve at knockout was closed, foreman was called and roustabouts were dispatched to repair the poly line.

Describe Area Affected and Cleanup Action Taken.\*

The flow line ruptured along the lease road (on the east side of the road) between the Lucy ALC State #7 and Lucy ALC State #4. Initial vertical and horizontal delineation samples were taken and sent to a NMOCD approved facility. A crew will be called to do clean-up of the area once analytical results are received, and all excavated soils will be disposed of at an approved NMOCD facility. Depth to Ground Water: >100' (approximately 125', Section 34, T21S-R31E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Yates Petroleum requests closure based off impacted soils (represented by analytical results) being excavated and disposed of at a NMOCD approved facility. Excavation was backfilled with clean-like materials.
