09/24/13: Dig out to get vac truck close enough to pull 75 BW out of hole.

09/25/13: Pulled 75 BW out of hole. Clean out mud & continue to clean out to hole.

09/26/13: Cleaned out to well. No casing. 6.00" dia hole. SDFN.

09/27/13: Weld 4'x4' plate 7.00' from bottom of 5-1/2" J55 csg & strip 4' piece of culvert material over csg. Work csg 7.00' into well. Set dwn csg on plate & level csg. Mix & pour 20 sx Quik-Crete cement behind csg. Held csg straight & back-fill hole until csg would not move. RD crane. Continue back-filling hole until dark. SD operations overnight.

09/30 – 10/01/13: Pumped 5 BFW dwn csg & made cut off. Weld on bell nipple & NU WH. MIRU Rig. NU BOP. Haul 17 jts 2-3/8" tbg to location. PU 2-3/8" NC on 2-3/8" tbg. RIH to 515'. Having to rotate past debris in several places. Well clean. PU 60'. SWI. SDFN.

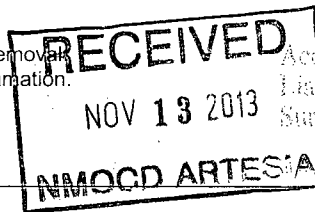
Note: Back-filled hole early this AM. Cementers set up for 7am tomorrow. BLM has been notified.

10/02/13: MIRU cement pumping equip. RIH to 483'. Break circ & pump 86 sx Class C Neat cement w/2% CC. Lost circulation. POOH & wait on cmt. RIH, tag cmt @ 60'. Pumped 85 sx Class C Neat cmt w/4% CC. No circulation. POOH & WOC. Tag cmt 5' from surface. POOH. ND BOP & WH. Fill csg w/cmt & watch for 30 mins, ok. RD cementers. Washed up lines. SDFN.

10/03/13: Cement fell 5" overnight. Clean location. RDMO.

Note: Waiting on dry hole marker placement (no welder available) and anchor removal.

10/09/13: Set dry hole marker & cut off anchors. Location clean & ready for reclamation.
