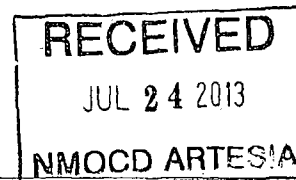

Mack Energy is proposing to change the Name of the Calgary Federal #2 to the Victoria Federal #2. Drill a vertical San Andres well. The TD and casing strings will also change as follows:

Surface Casing: Drill 12 1/4" hole to 450', run 8 5/8" 24# J-55 casing and cement w/450sx Class C+1% PF1, 14.8 ppg, 1.33 yield. Safety Factors C/B/T 6.808/5.537/5.9

Production Casing: Drill 7 7/8 hole to 3,500', run 5 1/2 17# L-80 casing and cement Lead w/225sx 35/65Poz C + 5%PF44 + 6%PF20 + .25#/sxPF46 + .125#/sxPF29 + 3PF46, 11.9 ppg, 2.02 yield. Tail 200sx PVL + 3%PF44 + 5%PF174 + 5%PF606 + 1%PF153 + .2%PF13, 13.0 ppg, yield 1.47. Safety Factors-C/B/T 3.456/2.644/2.580.

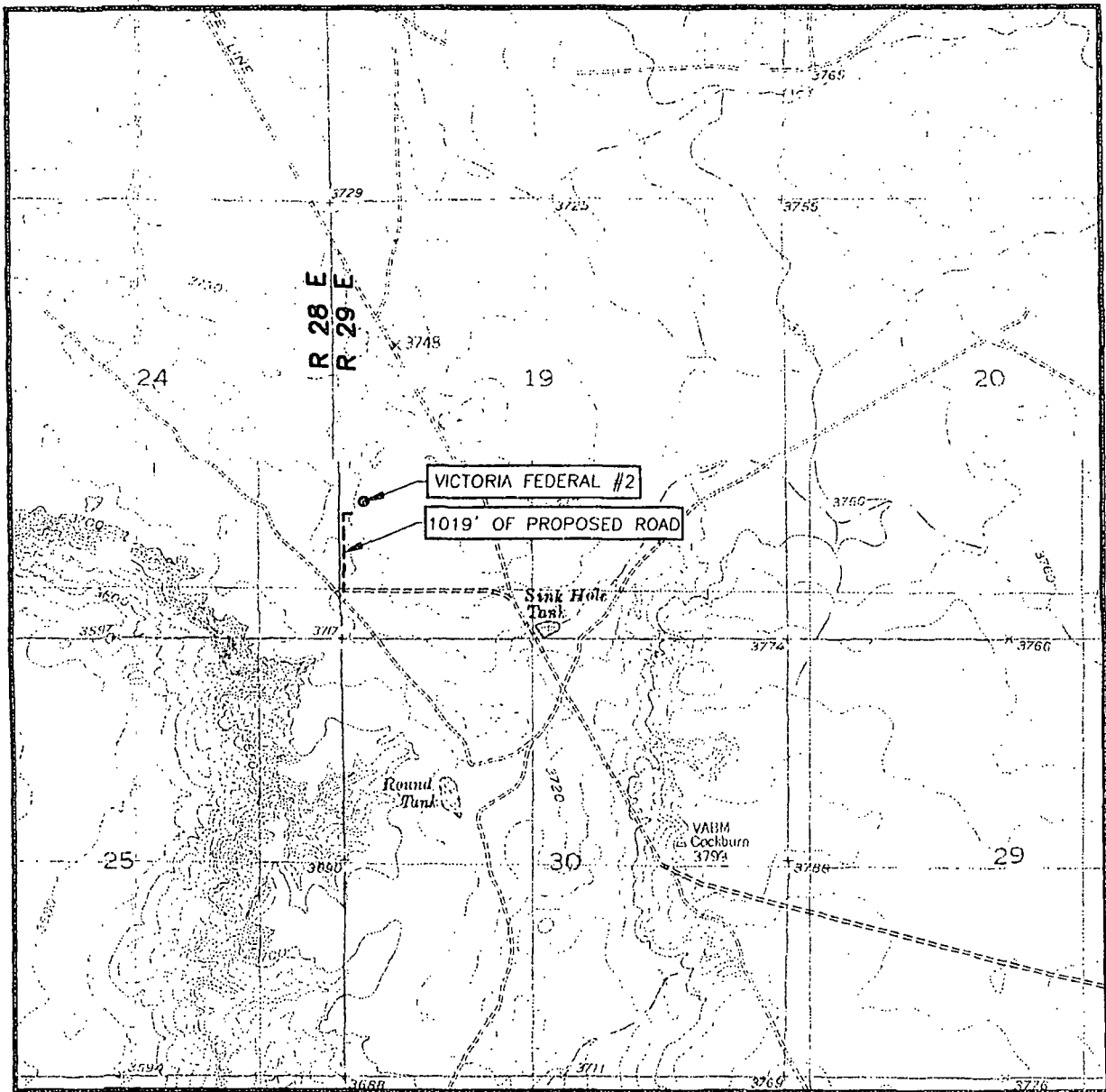

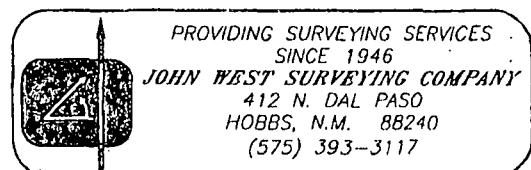

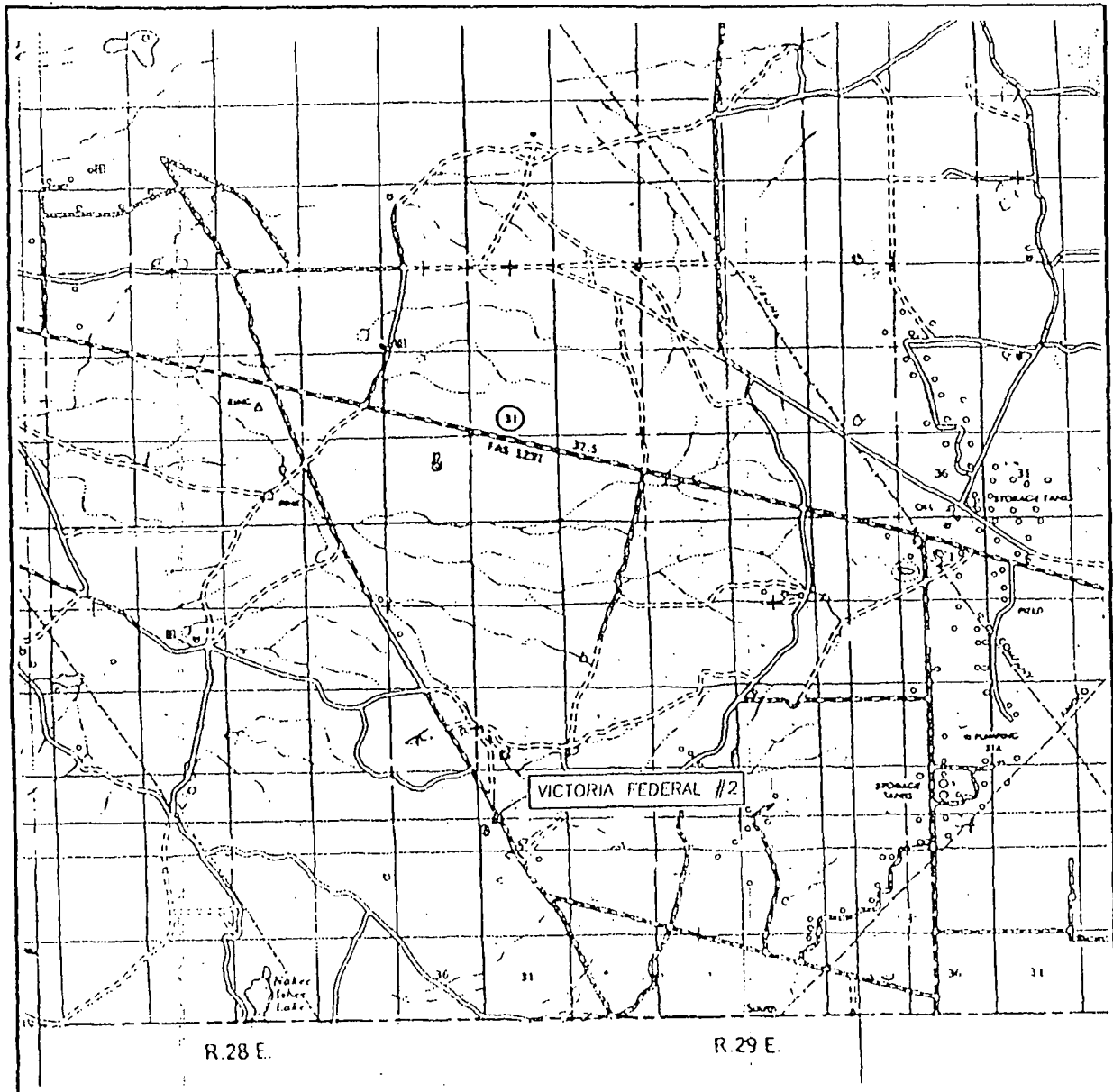
U.S.G.S. TOPOGRAPHIC MAP

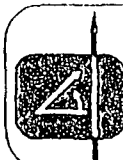
