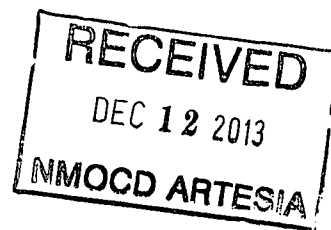

Drilled out with 8 3/4" bit.

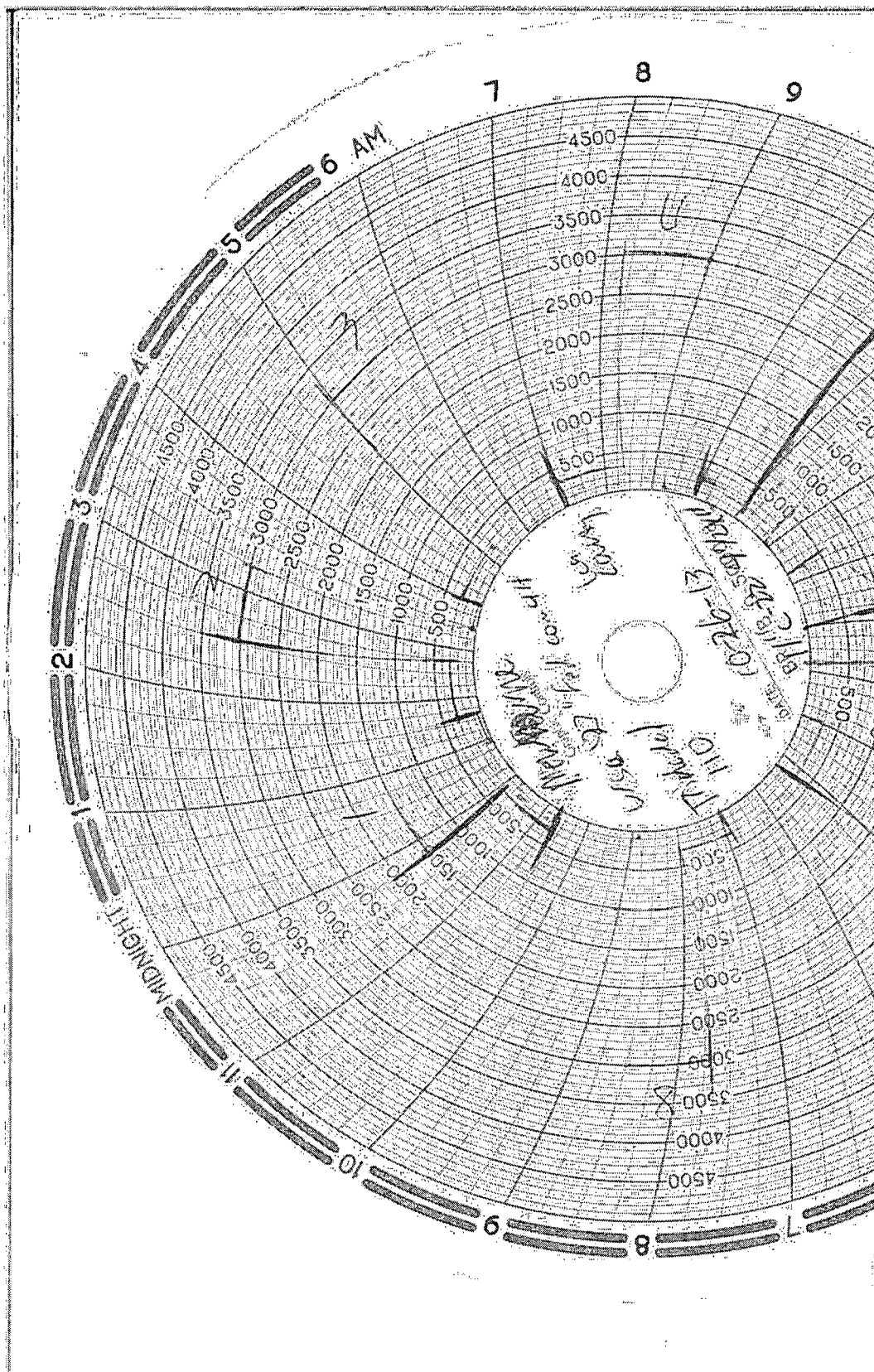

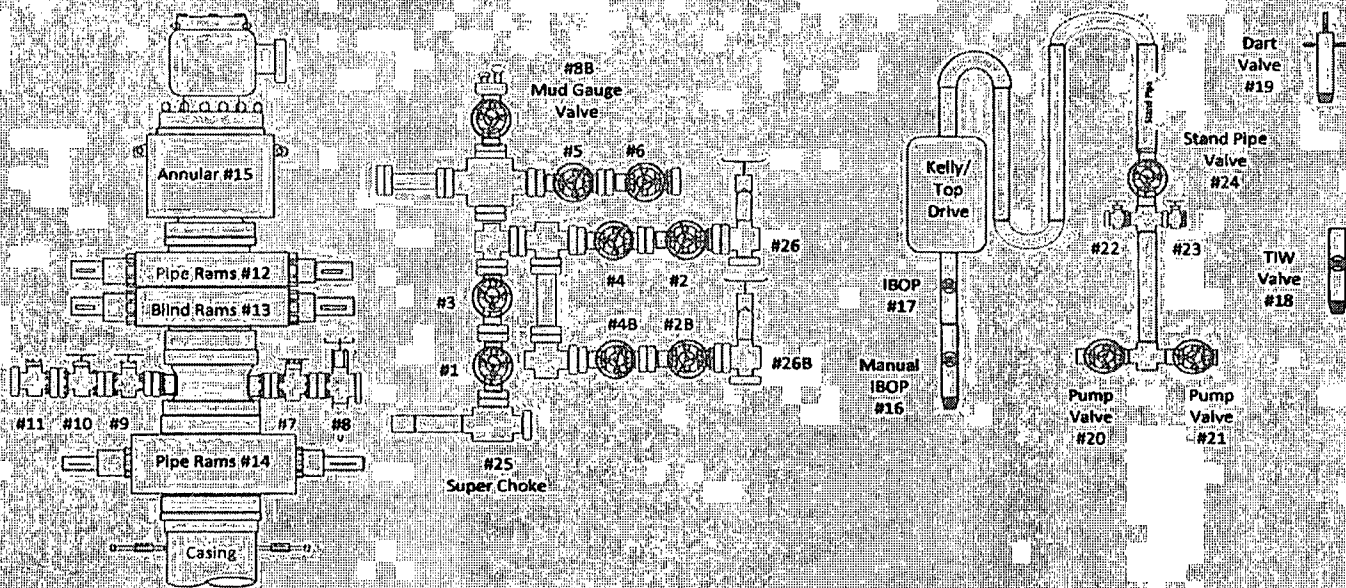
