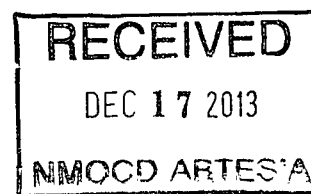

Drilled out with 6 1/8" bit.
