Drilled 7-7/8" hole to MDTD4816' on 12/1/13. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ MD4812'. Cmted w/lead 330 sx (579 cf) 35:65 poz "C" cmt w/5% PF-44, 6% PF-20, 0.2% PF-13, 0.125# PF-29, 0.4# PF-46, & 5# PF-42 & tailed w/630 sx (838 cf) cl "C" cmt w/0.5% PF-13, 0.2% PF-65, 0.2% PF-167, 0.125# PF-29, & 0.4# PF-46.. Circ 204 sx cmt to pit. Released drilling rig on 12/2/13. Plan to pressure test 5-1/2" csg during completion operations.
