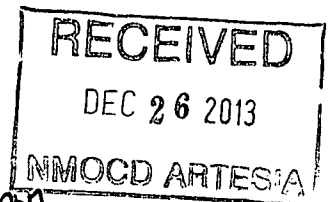

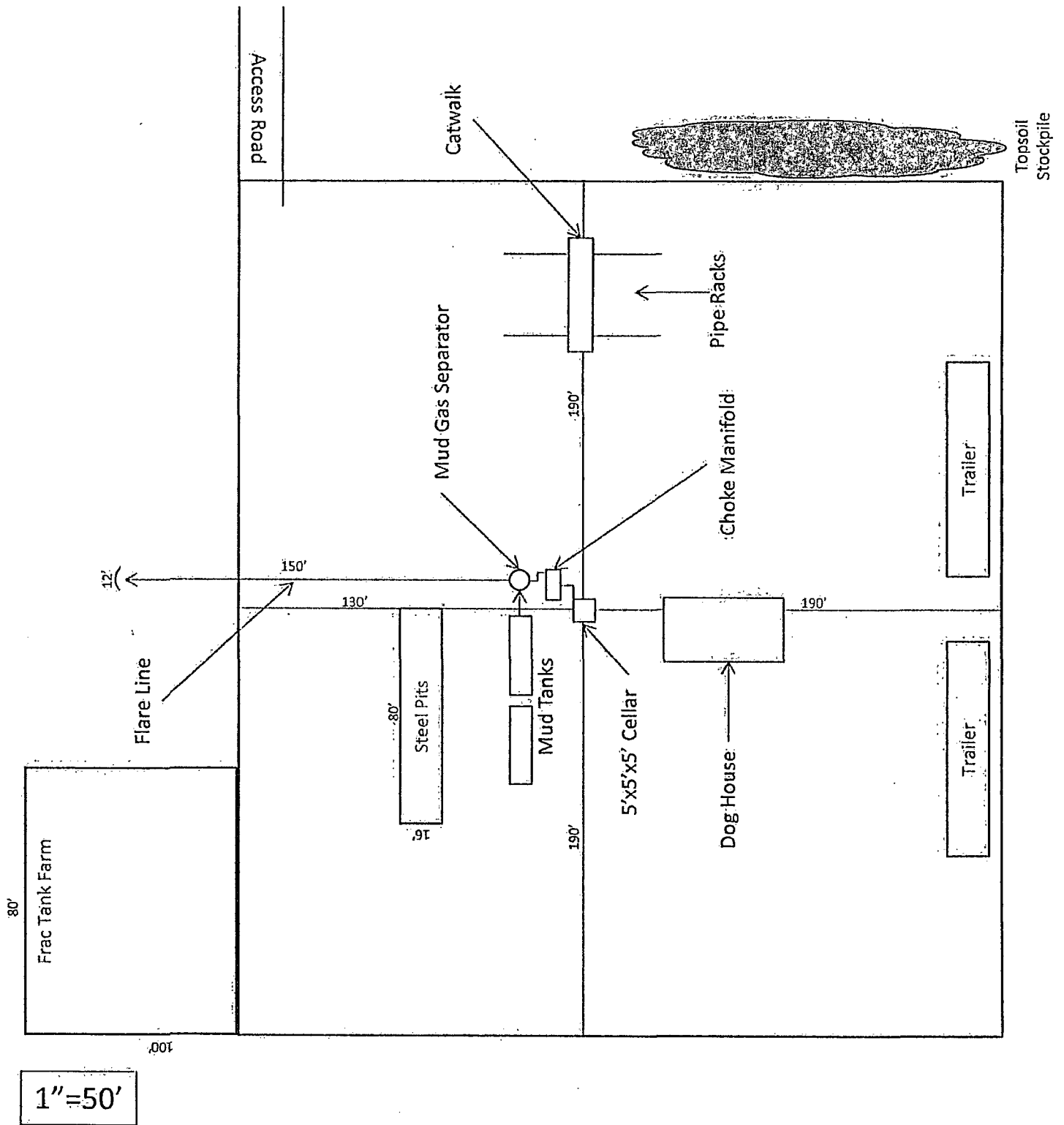


Exhibit D – Rig Diagram
