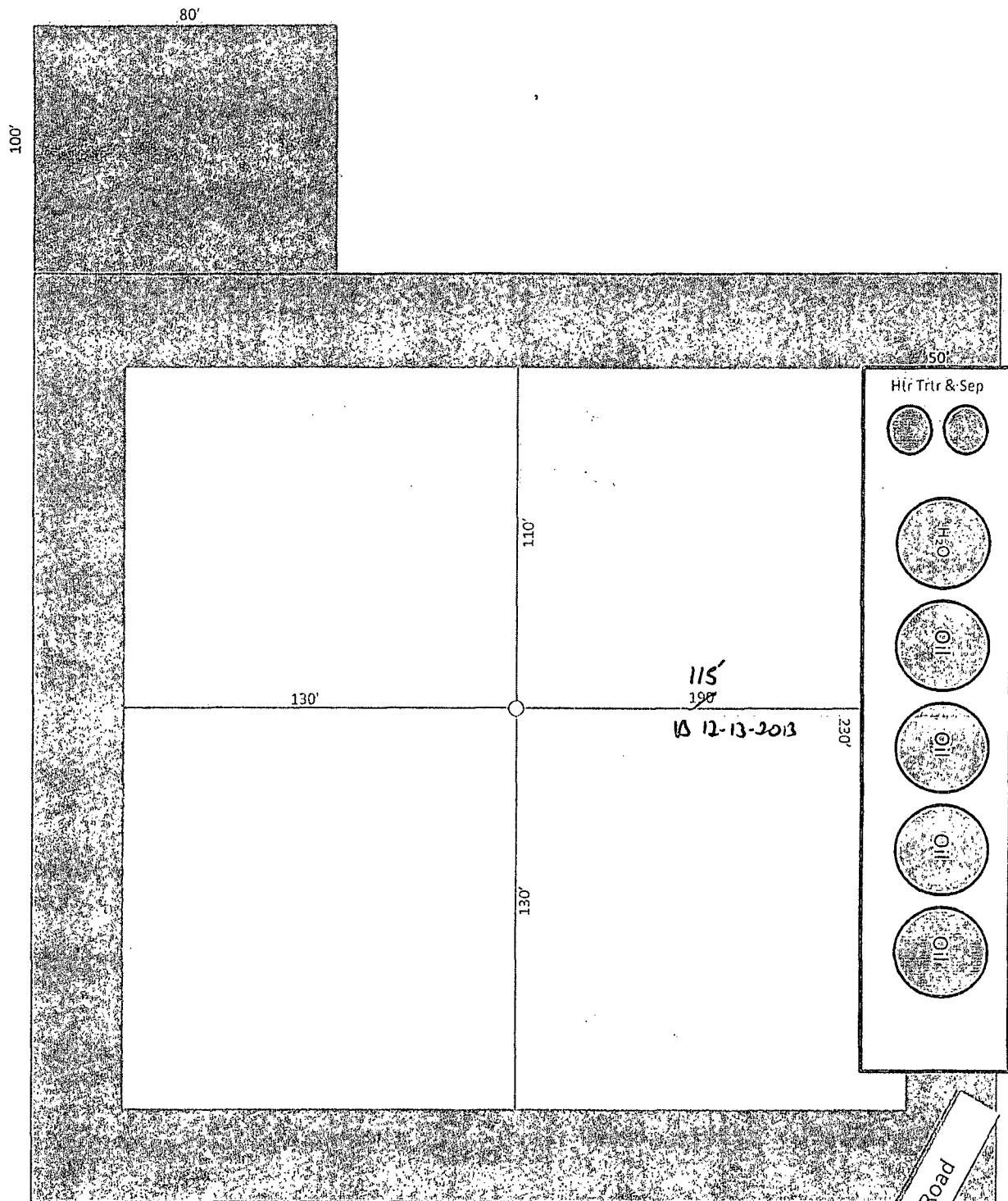


Exhibit D-1 Interim Reclamation Plat
