

On 1/19/14, while drlg the 17-1/2" surf hole of the Lee Fed #92(api# 30-015-41844), circ was lost @ 109' & well was dry drilled to csg point at 386'. 13-3/8" 48# H-40 STC csg was set @ 386' & cmt'd w/200 sx Cl C (14.4ppg, 1.62cuft/sx) followed by 560 sx Cl C (14.8ppg, 1.34cuft/sx). No returns were observed during primary cmt job. On 1/20/14, a temp log run indicating TOC @ approx 96'. Verbally appvd by BLM engineer, Jennifer Mason, a 4-pt tag was performed w/1" tbg & actual TOC was found @ 90'. With Jennifer Mason's approval, csg was cmt'd thru 1" tbg w/125 sx Cl C (14.8ppg, 1.34cuft/sx) & 42sx cmt circ to surf. Remedial cmt completed 1/20/14.


