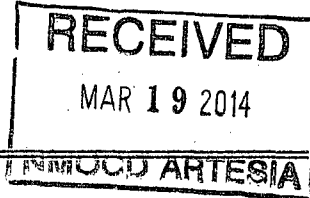

Spudded well on 1/28/14. Drilled 12-1/4" hole to 355'. Set 8-5/8" 24# J-55 csg @ 352'. Cmted w/280 sx (377 cf) cl "C" cmt w/0.25# C/F. Circ 71 sx cmt to pit. On 1/30/14, pressure tested 8-5/8" csg to 600 psi for 30 min-OK.

Drilled 7-7/8" hole to MDTD4768' on 2/2/14. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ MD4758'. Cmted w/lead 300 sx (579 cf) 35:65 poz "C" cmt w/5% salt, 6% gel, 2% R-3, & 0.125# cf & tailed w/670 sx (884 cf) cl "C" cmt w/0.5% PF-13, 0.2% PF-65, 2% PF-167, & 0.125# PF-29. Circ 60 sx cmt to pit. Released drilling rig on 2/4/14. Plan to pressure test 5-1/2" csg during completion operations.
