2/23/14 – NU BOP.

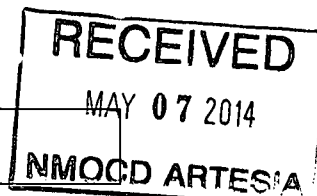
2/24/14 – Ran a gauge ring/junk basket to 7,800'. Set CIBP at 7,734'. Tested to 1000 psi for 10 mins, held good. Dump bail 35' cement on CIBP. Spotted 100 sacks Class "C" Neat at 6,075'.

2/25/14 – Tagged TOC at 5,474'. Spotted 25 sacks Class "C" Neat at 4,816'. Calculated TOC at 4,660'. Tested casing to 3000 psi for 30 mins. Lost 50 psi in 30 mins. Tagged cement at 4,667'. Logged to surface. Perforated Yeso 2,366' – 2,412' (47 holes). ND BOP.

4/1/14 – Acidized with 2000 gallons 20% HCL acid and frac'd with a total of 300,900# 100 Mesh, 16/30 and 40/70 Arizona sand. 2-7/8" 6.40# J-55 tubing at 2,629'.
