Open DVT and circulate mud for 4 hrs.Cement pumped (4/24/14) Stage 2: 205sks Halcem .20% HR-5+ .01250 lb/sk Poly-E-Flake, mixed at 12.3 ppg, yield 1.95 cuf/sk. Close DVT. No significant returns to surface. WOC for 18 hrs. Ran CBL.Drilled out DVT. Tested BOP 4/25/14 to 3000# for 30minutes. No pressure drop. Tested casing 4/25/14 to 1500# for 30 minutes. No pressure drop. ✓
