BOPCO L.P. is requesting to make changes to the 7" cement job for the PLU #393H. Due to complications during our 9-5/8" cement job, a gap resulted from 900 ft to 1,800 ft. To further isolate this gap in cement we are planning to bring cement back to surface on our 7" cement job. The volumes we plan to run are as follows: 450 sacks of 11 lbm/gal Tuned Light, with a yield of 2.35 ft<sup>3</sup>/sk. This change comes after speaking with Wesley Ingram on March 22, 2013.
