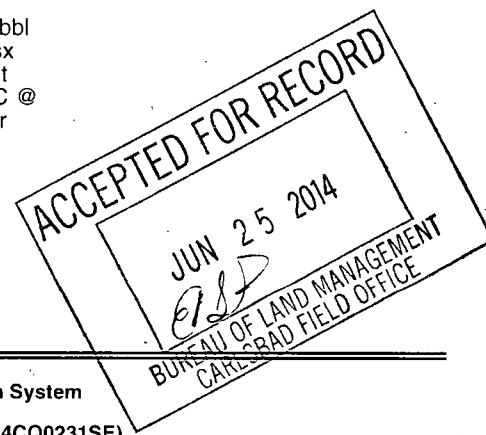

RIH & set 9-5/8" 36# J55 BTC csg @ 4217', pump 20bbl dyed spacer, cmt w/ 1120sx (376bbl) Light PPC w/ additives 12.9ppg 1.89 yield followed by 360sx (85bbl) PPC w/ additives 14.8ppg 1.33 yield, had full returns to surface during cmt job, but no cmt to surf, got back 5bbl dyed spacer, calc TOC @ 154', WOC. Notified BLM, RIH w/ temp log, TOC @ 460', sent temp log to BLM, WOC 24hrs. 4/22/14, pressure test 13-3/8" X 9-5/8" to 500#, hold for 30min, pressure bled down to 425#. Contact BLM, Chris Walls approved to continue drilling operation, put gauge on valve to monitor pressure while drilling. Install wearbushing and lock-in pins, RIH & tag cmt @ 4162', test csg to 2464# for 30 min. tested good, circ hole, drill new formation to 4233', perform FIT test to EMW 462# 11.0ppg MWE, good test.
