Drill a 17-1/2" hole to 212' w/fr wtr mud system, wt. 8.6-9.2, vis 32-34, set 13-3/8" casing & cement to surf. Drill a 12-1/4" hole to 2400' w/cut br mud system, wt 9.8-10.1, vis 28-30, set 9-5/8" casing & cement to surf. Drill 8-3/4" hole to 8350' w/cut br mud system, wt 8.7-9.3, vis 28, set 7" casing & cement to surf. Drill 6-1/8" open hole to 9450'. A DV-tool will be set @ +/-7000'.
