Drilled 7-7/8" hole to TD3607' on 7/4/14. Set 5-1/2" 17# J-55 production csg @ 3588'. Cmted w/lead 310 sx (590 cf) 35:65 poz "C" cmt w/5% PF-44, 6% PF-20, 0.2% PF-13, 0.125# PF-29, & 0.4# PF-46. Tailed w/375 sx (499 cf) cl "C" cmt w/0.3% FP-13, 0.2% PF-65, 0.3% PF-606, 0.125# PF-29, & 0.4# PF-46. Circ 88 sx cmt to pit. Released hole logs. Released drilling rig on 7/5/14. Plan to pressure test 5-1/2" csg during completion operations.
