Drilled 7-7/8" hole to TD5100' on 11/12/14. Landed 5-1/2" 17# J-55 csg @ 5089'. Cmted lead w/330 sx (634 cf) 35/65 poz C cmt w/5% PF-44, 6% PF-20, 0.2% PF-13, 0.125# PF-29, & 0.4# PF-46. Tailed w/625 sx (831 cf) "C" cmt w/0.5% PF-13, 0.2% PF-65, 0.125# PF-29, & 0.4# PF-46. Circ 129 sx cmt to pit. Ran cased hole logs. Released drilling rig on 11/14/14. Plan to pressure test the 5-1/2" csg before completion operations.
