11/5/14 - Casing had 110 psi, tubing had no pressure. Bled down casing. Pumped 25 bbls fresh water down tubing. Did not load. Pumped 30 bbls fresh water down casing to keep H2S gas downability under bond to plugging of the well bore. Unseated pump. NU BOP.

11/6/14 - Opened up well. Had 40 psi on casing. Bled down. Spot CIBP at 2401 ft. Tested lines to 2500 psi. Loaded tubing with 3 bbls. Apply 1200 psi. Set plug, plug was moving down hole. Picked up tubing to 2730 ft. Pumped 80 bbls fresh water. Did not break circulation. Spotted 100 sx Class C cement with 2% CaCl. Displaced with 1 bbl fresh water. Kent Caffall with Carlsbad BLM was on location to witness.

11/7/14 - Opened up well. Had no pressure. Tagged up on cement plug at 2680 ft. Pumped 55 bbls fresh water. Did not circulate. Spotted 100 sx Class C cement with 2% CaCl. Calc TOC at 1160 ft. WOC. Tagged up at 2420 ft. Pumped 150 sx Class C Neat cement from 2420 ft up to surface. Topped well off with 20 sx Class C cement. Well standing full.
