Lead cmt 1150 sx Standard Lite mixed @ 12.9 ppg & 1.92 cuft/sk.  
Tail cmt 200 sx Standard mixed @ 14.8 & 1.33 cuft/sk.

Final circulating pressure 892 psi @ 3 bpm, bumped plug with 1400 psi, released pressure, recovered 1 bbl of fluid, floats held. Full returns throughout job, circ 68 bbls of cmt to surface.

Tested casing for 30 minutes to 1500 psi. Test good.
