

Devon Energy Production Company, L.P. respectfully requests adding a Pilot Hole in the 8-3/4" Production Hole to a depth of 9,155 ft TVD. Whole cores will be taken in the 3rd Bone Spring Sand, and a full suite of wireline logs will be run in the production hole. After finishing the Pilot Hole evaluation, an Open-Hole Whipstock will be oriented, set, and cemented in place. The Whipstock will be placed to Kick-Off at 8487' with 2-7/8" tail pipe to the total depth of the Pilot Hole at 9155'.
